THIS FORM MUST BE COMPLETED FOR EACH PARTICIPANT

Two Bayz Ranch, Bettina and Katja Zimmer, family all heirs, employees and volunteers are hereinafter known as "THIS STABLE". The term "HORSEBACK RIDING" herein shall refer to riding or otherwise handling of horses, ponies, mules or donkeys, whether from the ground or mounted. The terms "STUDENT" or "RIDER" shall herein refer to a person who rides a horse mounted or otherwise handles or comes near a horse from the ground. The terms "I", "ME" "MY" shall herein refer to the above registered stunned rider or the parents or legal guardians thereof in a minor.

IT IS HEREBY AGREED AS FOLLOWS:

I, the undersigned, do for myself or on behalf of my child or legal ward, hereby voluntarily request to participate in riding instructions and activities as a student at THIS STABLE, and that student will either ride his or her own horse, or horses provided by THIS STABLE for instructional purposes.

That parent or guardian and student understand that if a horse is frightened or provoked it may
divert from its training and act according to its natural survival instincts which may include, but
are not limited to: stopping short, changing directions or speed, bucking, rearing, kicking, biting
or running from danger. Horses are 5-15 times larger and extremely powerful than a human. If
a rider falls to the ground, the distance will generally be 3 ½ feet to 5 ½ feet and may result in
injury to the rider.
THIS STABLE dos not allow pregnant women to ride.
I understand these risks and voluntarily assume these risks and dangers.

That parent or guardian and student understand that upon mounting the horse and taking up the rider is in primary control of the horse. The rider's safety largely depends on his/her actions, ability to stay balanced, follow simple instructions and THIS STABLE is not responsible for the result or student's actions or inactions. Student further agrees not to abuse, misuse or deliberately agitate the horse
I have been advised that students must wear a SEI certified safety helmets while riding and around the horses to prevent horse related head injuries. Bicycle helmets are not allowed.
I have been advised that riders need to wear appropriate clothing while riding. Closed toed shoes, preferably boots with small heals, flip flops and sandals are not allowed on or around horses. Jeans or breeches preferred. Shorts are allowed in western saddles.
Student is currently covered by accident-medical insurance and will remain insured for the duration of all riding instructions at THIS STABLE. I further understand that should medical treatment be required, the current insurance will be used to cover all current and future payments of incurred bills.
I have read and agree to the BARN RULES, which must be followed by all riders, parents and other children while on the premises of THIS STABLE.
I have read and agree to the PRE-RIDE INSRUCTIONS, which must be followed by all riders, parents and other children while on the premises of THIS STABLE.
I have read and agree to the TRAIL RIDE INSTRUCTIONS (if applicable), which must be followed by all riders and parents while on the premises of THIS STABLE or on trails.
LIABILITY RELASE: I AGREE that I am responsible for bodily injury or property damage which I, my child or legal ward should sustain on THIS STABLE's premises and/or trails and/or while riding a horse, and/or while in transit to or at horse shows, trails, or similar expeditions, and for any time I, my child or legal ward shall lose from employment or school or other activity, and for medical expenses or any other expenses incurred because of such bodily or property damage and that I hereby, for myself, my heirs, administrators and assigns release and discharge the owners, operators, sponsors of THIS STABE and ITS ASSOCIATES, respective servants, agents, officers and all other participants of and from all claims, demands, actions and causes of action for such injuries sustained on my person, m child or legal charge or property.

PRE-RIDE INSTRUCTIONS Welcome to Two Bayz Ranch.

We would like to go over some important safety rules and tips so that all who come to ride and watch can have a fun and safe ride and experience.

We do not have public restrooms. Please plan accordingly.

We do not allow any alcohol or drinking on the Ranch. It can be dangerous to the participants and horses.

We do not allow smoking on or around the Ranch. Barn fires are devastating.

TRAIL RIDE INSTRCTIONS

It is highly recommended, before you ride, you remove wallets from your back pockets and make sure that anything in your pockets which can fall is take n out or secured in a button or zip pocket. Car keys can be lost very easily. Keys can be left at the office. Valuables should be locked in your car.

NO cell phones, cameras or drinks on rides. This is a safety precaution and does not divert attention from the horse or hinder the ability of the rider to use the reins and keep control of the horse at all times.

We will provide photo opportunities on the ride.

We do not allow smoking or rides.

No flip flops or sandals on rides. Tennis shoes are ok, boots with small heals are preferred.

Children must be 10 years or older to go on rides. Pregnant women are not
