RIDING INSTRUCTION AND LIABILITY RELEASE FORM

THIS FORM MUST BE COMPLETED FOR EACH PARTICIPANT

Two Bayz Ranch, Bettina and Katja Zimmer, family all heirs, employees and volunteers are hereinafter known as "THIS STABLE". The term "HORSEBACK RIDING" herein shall refer to riding or otherwise handling of horses, ponies, mules or donkeys, whether from the ground or mounted. The terms "STUDENT" or "RIDER" shall herein refer to a person who rides a horse mounted or otherwise handles or comes near a horse from the ground. The terms "I", "ME" "MY" shall herein refer to the above registered student rider or the parents or legal guardians thereof in a minor.

IT IS HEREBY AGREED AS FOLLOWS:

I, the undersigned, do for myself or on behalf of my child or legal ward, hereby voluntarily request to participate in riding instructions and activities as a student at THIS STABLE, and that student will either ride his or her own horse, or horses provided by THIS STABLE for instructional purposes.

We do not allow pregnant women to ride.

That parent or guardian and student understand that if a horse is frightened or provoked it may divert from its training and act according to its natural survival instincts which may include, but are not limited to: stopping short, changing directions or speed, bucking, rearing, kicking, biting or running from danger. Horses are 5-15 times larger and extremely powerful than a human. If a rider falls to the ground, the distance will generally be 3 ½ feet to 5 ½ feet and may result in injury to the rider.

THIS STABLE does not allow pregnant women to ride.

_____ I understand these risks and voluntarily assume these risks and dangers.

That parent or guardian and student understand that upon mounting the horse and taking up the rider is in primary control of the horse. The rider's safety largely depends on his/her actions, ability to stay balanced, follow simple instructions and THIS STABLE is not responsible for the result or student's actions or inactions. Student further agrees not to abuse, misuse or deliberately agitate the horse

_____ I have been advised that students must wear a SEI certified safety helmets while riding and around the horses to prevent horse related head injuries. Bicycle helmets are not allowed.

_____ I have been advised that riders need to wear appropriate clothing while riding. Closed toed shoes, preferably boots with small heels, flip flops and sandals are not allowed on or around horses. Jeans or breeches preferred. Shorts are allowed in western saddles.

_____ Student is currently covered by accident-medical insurance and will remain insured for the duration of all riding instructions at THIS STABLE. I further understand that should medical treatment be required, the current insurance will be used to cover all current and future payments of incurred bills.

_____ I have read and agree to the BARN RULES, which must be followed by all riders, parents and other children while on the premises of THIS STABLE.

_____ I have read and agree to the PRE-RIDE INSRUCTIONS, which must be followed by all riders, parents and other children while on the premises of THIS STABLE.

_____ I have read and agree to the TRAIL RIDE INSTRUCTIONS (if applicable), which must be followed by all riders and parents while on the premises of THIS STABLE or on trails.

_____ I understand the 24 hour cancelation policy. Appointment times are limited. If you must cancel your appointment, we respectfully request 24 hour notice. Missed appointments, or appointments cancelled without 24 hour notice, will require full lesson fee. We offer a onetime courtesy fee waiver.

LIABILITY RELEASE: I AGREE that I am responsible for bodily injury or property damage which I, my child or legal ward should sustain on THIS STABLE's premises and/or trails and/or while riding a horse, and/or while in transit to or at horse shows, trails, or similar expeditions, and for any time I, my child or legal ward shall lose from employment or school or other activity, and for medical expenses or any other expenses incurred because of such bodily or property damage and that I hereby, for myself, my heirs, administrators and assigns release and discharge the owners, operators, sponsors of THIS STABE and ITS ASSOCIATES, respective servants, agents, officers and all other participants of and from all claims, demands, actions and causes of action for such injuries sustained on my person, m child or legal charge or property.

_____ I /WE THE UNDERSIGNED, HAVE READ AND UNDERSTAND THE FOREGOING AGREEMENT, WARNINGS, RELEASE AND ASSUMPTION OF RISK. I/WE FURTHER ATTEST THAT ALL FACTS RELATING TO THE APPICANT'S PHYSICAL CONDITION, EXPERIENCE, RELATIONSHIP TO GAURDIAN/PARENT AND AGE ARE TRUE AND ACCURATE.

BEING OF LEGAL AGE AND OF SOUND MIND AND NOT BEING UNDER THE INFLUENCE OF ALCOHOL, DRUGS OR INTOXICANTS HAVE READ AND UNDERSTAND THE FOREGOING AGREEMENT AND RELEASE.
